Testing Methods

JIS L 1903:2011 (Revised on 22 March 2011)

Fill Power (DOWN POWER) As of 2012, JDFA has a new Fill Power system. A stainless steel metal cylinder uses a 94.3g weight. The down is steam conditioned (different than IDFB) and the results are reported as "DOWN POWER" in cm³/g.

Minimum Down ≥ 50%

JDFA Species (Goose)

Products can be labeled by Goose if 90% of the plumage is of that species.

*Species are not required to list on labels.

*When it is listed as "Goose Down", Feather detail is not required.

*This will not listed on gold labels

Cleanliness Requirements

Oxygen Number $\leq 4.8 mg$ Turbidity $\geq 500 mm$ Fat & Oil $\leq 1.0\%$

Note: When the product meets criteria for each label, only JDFA members can use the Label on their products.
